Thank you for your interest in being a Vendor / Exhibitor at this year's Sebastian Clambake! Space is limited and sites are assigned on a first-come, first-served basis, so we recommend reserving your site as soon as possible. **Returning** Vendors have will receive last year's site if postmarked in prior to **August 1, 2017**. This festival is a charity fundraiser. **No vendors offering food or beverage for on-site consumption will be allowed; the Sebastian Clambake Foundation will provide these items.** **Political vendors are not permitted at this event.** Vendors / Exhibitors are responsible for supplying tents, tables, an 5lb ABC Fire Extinguisher, and other equipment necessary for display.

Setup can begin no earlier than 12:00 Noon on Thursday, and **must be completed by 12:00 Noon** on Friday. Limited security will be available Thursday night. Sites will be located both in Riverview Park and along East Sebastian Boulevard. Sites will be divided into two sizes:

"**Tent Sites**" are a maximum of 10' x 10'.

Vendor / Exhibitor Agreement
November 3rd, 4th & 5th

1. Exhibitors must not deviate from the product / information described in their application.
 2. There shall be no political displays or politicking anywhere on event grounds.
3. No oversized, unmanageable exhibits. Stay within your assigned site, including back side.
4. Vendor / Exhibitor displays must be staffed always by at least one adult. No children under 18 should be left unattended.
4. All displays, tents, tables, exhibits, etc. **MUST** be a minimum of 3' off of the sidewalks. The line will be marked for you. You **will be required** to make any adjustments to your display space if requested to do so at any time during the event by any staff member.
5. All exhibits must be set up and ready for business by Friday noon. NO EXCEPTIONS
7. **Absolutely NO VEHICLES ARE ALLOWED in the Park. You must park in designated parking areas ONLY and be capable of moving items in by cart or carriers.**
6. No pets are allowed in the park during events.
7. No smoking is allowed in the park.

There will be **ABSOLUTELY NO** changes to location if you are not satisfied with your designated site.

10. No soliciting is allowed outside of your booth area. If you are warned and then continue, you will be asked to leave the Festival. This includes any product or displays outside of your area.
11. Exhibitors are responsible for cleaning up their area before leaving on Sunday evening. A \$20 cash deposit will be held by the vendor coordinator until inspected and released.
12. No water, food, or beverage may be sold **OR** given away free from your booth.
13. No adult-oriented merchandise with sexual connotations or merchandise that could be considered drug paraphernalia will be allowed.
14. No guns will be allowed in the park for any reason.
15. Vendors/Exhibitors are **not** entitled to complimentary food or drink from the Clambake booths.
16. Valuables should not be left unattended. The Sebastian Clambake Foundation does not assume responsibility or liability for theft, damage, or other loss of vendors' property and/or possessions.
17. No refunds will be issued due to bad weather or acts of nature.
18. Any Vendor / Exhibitor violating any of these rules and regulations will be required to leave without refund of entry fee.
19. You will be notified of your booth space prior to October 15, 2017. As of October 15, 2017, no refund of your registration fee will be given for any reason.
